### **Tools Required**

Electric Knife, or other device capable of cutting foam. Sharpie, or other marker capable of marking paper and foam.

#### **SAFETY**


Always wear proper personal protective equipment and exercise caution when using cutting tools. Be mindful to keep fingers and other body parts clear when using manual or power tools to cut materials.

Stealth is not responsible for improper cutting or workmanship issues that may occur during the build of your cushion.

#### **Cushion Construction**

 Remove the cushion construction materials from the box and verify that you have received all the selfadhesive foam pieces necessary to construct the cushion


Locate the cushion sizing template in your kit.



2. Place the Base Foam (D) on a flat assembly surface, paper side up, and align the Sizing Template radius as shown in the image to the left.

Align the radius of the Base Foam with the radius of the Sizing Template.

 Using the Sharpie or other marker, mark the lines on the base foam corresponding to the final size of your cushion using the provided holes in the template as shown in the image to the right.



4. Using the electric knife, or other foam-cutting tool, cut the base foam along the lines drawn in Step 2.





5. Peel the paper adhesive protector from the base foam exposing the adhesive surface. Return the base foam to the assembly surface, adhesive side up.





6. Measure the first
Anti-Thrust Wedge
(E) and cut it to the proper depth. Align the straight edge with the front of the base foam and the angled edge facing the rear of the cushion. Press it into the adhesive of the base foam.


 Carefully flip the assembly and hang the adhesive portion of the base foam off the edge of the assembly table.


Trim the excess foam from the side of the anti-thrust wedge. If more than 0.5" of anti-thrust height is required, peel the paper adhesive protector from the installed anti-thrust wedge, and install another wedge piece, aligning the angled edges to create a smooth ramp.



Trim the excess foam to match the side and front edge of the base foam (see above).

8. To continue assembly of the upper portion of the cushion, peel the paper adhesive protector from the top anti-thrust wedge to expose the adhesive.





 Determine the longer dimension of the Open Cell Foam (C) and fold it in half.

> Lay the foam layer flush with the rear of the base foam and slowly press the foam to adhere the layers.

Press the foam along the anti-thrust ramp and continue adhering the foam to the adhesive on the anti-thrust wedge.



10. Flip the assembly onto the open cell foam layer and trim the excess foam along the straight edges of the base foam layer. Following the edge of the radius on the base foam layer, trim the excess open cell foam from the assembly.





 Locate the two Adductor Wedges (H, J). There will be two adhesive-backed sides on each wedge. Peel the protective paper off of the side adjacent to the right angle on one of the adductors.

Starting at the front of the cushion, press the adhesive side of the wedge into the open cell foam, and follow the contour to the back of the cushion.

Repeat this process with the other adductor wedge.






12. Locate the proper abductor wedge in the kit and install it as shown in the image, flush to the front edge of the cushion.








13. Using the electric knife, or other foam cutting tool, trim the adductor wedges to follow the rounded edge of the rear of the cushion.






14. Peel the adhesive layer from all surfaces to begin the middle layer assembly.

15. Align the edge of the Soft Sunmate FRG (B) flush with the rear of the cushion on the side with the adductor and abductor wedges. Slowly lay the Soft Sunmate FRG towards the front part of the cushion and press it firmly into the adhesive.



16. Flip the cushion and trim excess foam smoothly from the edges.








17. Foam is trimmed and ready for the next step.

18. Peel the adhesive protection layer from the Extra-Soft Sunmate (A), and fold it in half with the adhesive layer on the outside.





19. Align the edge of the foam with the rear edge of the cushion and slowly lay it forward to the front edge of the cushion. Press firmly to affix the adhesive on the top surface of the cushion.





#### NOTICE


Adhere the foam to the top of the cushion ONLY at this time. Do not press the foam to the sides of the cushion.







20. Waterfall the Extra-Soft Sunmate (A) over the front edge of the cushion and press it firmly into the other foam layers. Using your electric knife, or other foam-cutting tool, trim the excess foam from the bottom front edge of the cushion.





21. Once the bottom, front edge has been trimmed, continue trimming the excess foam from around the edges of the cushion. Follow the curves and contours of the cushion to achieve a straight, smooth appearance.





Construction of your cushion is now complete. It can be zipped into the cover and used immediately.

### **Dealer Assistance**

During first time use by the client, it is advised that the dealer or service technician assists and explains the configuration to the customer (the user and/or the attendant). If needed, the dealer can make final adjustments.

### **User Testing**

It is important that the customer is fully aware of the installation and how the product can be adjusted in order to gain the best positioning possible. As a dealer, proceed as follows:

 Explain and show the client how you have executed the installation, and explain the function.

Have the user test the position of the product:

- Is the Custom Cushion in the proper position for the client?
- Can the user safely operate the chair in the position in which they are seated?
- Is the placement of the Custom Cushion in an optimal position for the client?

### **Conditions of Use**

The Custom Cushion is intended for use as installed by the dealer, in accordance with the installation instructions in this manual.

- The foreseen conditions of use are communicated by the dealer or service technician to the user and/or attendant during the first time use.
- If the conditions of use change significantly, please contact your dealer or a qualified service technician to avoid excessive wear and tear or unintended damage.

#### Maintenance

### Cleaning

- Hand wash the cover and liner with mild, soapy water or detergent and drip dry.
- Foam pad should not get wet.



Do not machine wash or dry.

Do not hand wash in water temperatures above 160°F (70°C)

Do not immerse the foam in water.



Institutions must clean and disinfect this product between multiple patient uses.

#### Disinfection

 Wipe surfaces gently with a cloth dampened with a household disinfectant.

### **Disposal**

If a product is to be disposed of, all components on the product must be disposed of properly in accordance with the applicable environmental protection regulations in the respective country.
